(57) **ABSTRACT**

The combination of an actuator housing assembly and a bolt mechanism assembly adapted to enable attachment and detachment, the assemblies being carried on opposed sides of a panel. The bolt mechanism assembly comprises a sliding bolt assembly one element of which is adapted to latch to a striker.
